ISAAC OnTheGo enables drivers to accomplish trip related operations easily and quickly. It comes on a rugged, weather-resistant tablet, and includes features drivers can use both inside the vehicle cab, and around the vehicle when performing pre-trip inspections.



Hours of service









Dispatcher trip instructions

- Provides drivers with a view of dispatcher trip instructions, as entered via your organization's Transport Management System (TMS).
- Each trip shows the list of stops and planned activities.
- Allows for less than truckload (LTL) pickups and deliveries.
- The driver confirms the planned activities as they are carried out, based on the workflow established by the dispatcher. The driver can also enter unplanned activities.
- If CoPilot[™] Truck is activated, the next stop's address is automatically entered in the navigation system on the dashboard.


- The dashboard displays automatically when the vehicle is travelling, and other functions are unavailable to ensure safe driving.
- Drivers use the dashboard to keep tabs on hours of service and driving performance.
- The dashboard displays the remaining driving time based on the hours-of-service regulations (Canadian or U.S. regulations).
- The dashboard displays performance indicators established and configured by the system administrator (ISAAC Coach, speed, and coasting).
- The dashboard shows the next planned stop based on the dispatcher trip instructions.
- If CoPilot[™] Truck is activated, the navigation screen appears on the dashboard and route instructions can be toggled on and off.
- If Active Traffic[™] in CoPilot^{MD} is activated, traffic information is displayed in a colored bar on the right-hand side of the dashboard.
- The driver receives notifications of hours-ofservice violations, alarms detected by the gateway (ex. excessive speed, hard turns, etc.), and inspection violations (expired inspection, unrepaired minor defect over 48 hours, etc.).
- If Drivewyze is activated, the driver receives instructions on whether to bypass, pull in or follow the road signs.








Messages


- Dispatchers and drivers can communicate efficiently thanks to two-way messaging.



- All team members can be logged into the tablet at the same time and switch between profiles as needed.
- As Secondary Driver, view your messages, logbook, and all other information while the Main Driver is driving or on duty.
- The driver identified as the *Main* driver is assigned the driving time.
- Switch driver roles (Secondary to Main) to ensure the correct driver is assigned the driving time.
- Transfer driving time from one team member to another if you forget to switch driver roles and driving time is incorrectly assigned.
- Generate a teammate's hours of service report during a roadside inspection.

Reminder

Canadian and American regulations stipulate that, during driving, the ELD-compliant tablet must be mounted in a fixed position and be visible to the driver when they are in a normal driving position.

Turning on the tablet

1. Press the power button located on the top of the tablet.

If the tablet is powered off (as opposed to in *sleep* mode), keep the button pressed for about 3 seconds.

The location of the power button varies depending on the tablet model.

Startup may take up to 30 seconds.

Starting ISAAC OnTheGo

1. Tap the ISAAC OnTheGo icon on the home page.







Logging in and logging out

To log in:

- 1. Tap the Driver Identification field.
- 2. Enter your username and password using the on-screen keyboard.
- 3. Tap **GO**. The dashboard displays after logging in.

Note that if you begin driving before logging in, a warning indicating to stop the vehicle and log in appears.





Note that if the system is ELD compliant, and you are exempt from ELD compliance, a message will appear upon login and logout indicating the exemption and the reason.
















Getting around in ISAAC OnTheGo – Basic information and features

- 1. The application bar at the top of ISAAC OnTheGo pages displays:
 - the menu icon lacksquare
 - the tablet's connection status with the router aboard the vehicle , and with the main server via the cellular network.

 - an icon to rapidly send precomposed emergency messages .
 - an icon for displaying driver notifications .
- 2. The header section displayed on most ISAAC OnTheGo pages contains:
 - the user name
 - the vehicle number and hooked equipment
 - the active trip number
 - the hours-of-service display mode (Canada or U.S. regulations)
- <u>3.</u> The main menu provides access to the various features of ISAAC OnTheGo.





Note that the **tablet's return button** is not active on some pages.

In such cases, use the buttons and menu options appearing on the page to navigate in ISAAC OnTheGo.



Confirming an automatic operating zone change

When an operating zone change is detected:

<u>1.</u> Tap **Confirm** to confirm the operating zone change.

Note that the system detects the vehicle's location and displays the remaining driving time, violations, and notifications according to the vehicle's position. The message confirming the change appears as soon as the driving stops after crossing into a new zone.

Changing the operating zone manually

- <u>1</u>. Tap the current operating zone (CAN or U.S.) on the header.
- 2. Select a new operating zone from the list.

 Note that the marker icon ☐ indicates the operating zone detected by the system's GPS.
- 3. Enter an Explanation note if needed.
- 4. Tap Confirm.
- 5. Tap **Summary** to view the recap of the chosen operating zone.

Changing the hours-of-service regulation

- 1. Tap the **RECAP** tab from the daily log.
- Tap HOS Settings.
- 3. Select an Operating Zone.
- 4. Select a Regulation for that operating zone. Note that the HOS Limitations displayed change according to the regulation selected.
- 5. Tap Confirm.






Confirming the new day start time

1. Tap Got it! to confirm you were advised of the new day start time.

Note that the new day start time confirmation appears only after a full cycle reset is completed.




Adjusting the screen's brightness

- 1. On the ISAAC OnTheGo application bar, tap the **brightness** icon .
- 2. Select the desired brightness mode:
 - Day and night modes (for all tablet models except G1) can be customized and selected at will.
 - Automatic setting (M models only) will adjust brightness according to ambient lighting.
- <u>3.</u> Slide the bars to adjust the brightness for the desired mode.
- **4.** Tap **OK**.

When driving with the Dashboard in normal view, you can toggle between the day and night modes with one tap on the screen if one is already selected.







Viewing the odometer value in ISAAC OnTheGo

ISAAC OnTheGo shows the vehicle's odometer value on some pages (ex. the daily log).

The value from ISAAC's system may differ from the value shown on the vehicle dashboard.

You can display ISAAC OnTheGo's odometer value of reference, which is taken from the vehicle's network (CAN).


1. On the ISAAC OnTheGo application bar, tap the menu icon and then select **Odometer** from the drop-down list.


The odometer value appears on screen.

Pairing a Bluetooth printer for crude haul activities

- 1. On the ISAAC OnTheGo application bar, tap the menu icon and select **Bluetooth printer** from the drop-down list.
 - The list of available printers appears in alphabetical order.
- 2. Select the printer you want to pair with and tap **OK** to confirm.
 - The tablet is pairing with the printer.
 - Note that only one printer can be connected at a time. Selecting another printer will end the previous pairing.
- 3. The connected printer is first on the list. Tap **OK** to exit the printer pairing page.









Good to know

- ISAAC OnTheGo enables the *Main Driver* and *Secondary Driver(s)* to be logged into the vehicle's tablet at the same time and switch between profiles as required.
- Drivers can generate or transfer their teammate's hours of service report during a roadside inspection without changing profiles.
- The Secondary Driver(s) can use the tablet to view their messages, logbook and all other information while the Main Driver is driving or on duty.
- The Main Driver is assigned the driving time. The Team page allows drivers to switch driver roles when it's the Secondary Driver's turn to drive. The Secondary Driver becomes the Main Driver and is therefore assigned the driving from that point on.
- Driving time can be transferred between two team members if drivers forgot to switch roles and driving time was incorrectly assigned.
- To log in, log out, or switch driver roles, the vehicle must be stationary.
- A driver appearing on the team page, but who is not among the current team members, can be removed from the list without affecting his hours-of-service status.

Accessing the Team page

1. Tap the team icon

The *Team* page is displayed.







Logging in as secondary driver

As *Secondary Driver*, you can access your messages, logbook, and all other information while the *Main Driver* is driving or on duty.

From the **Team** page:

- 1. Tap the Add Driver button.
- 2. Enter your username and password using the on-screen keyboard.
- 3. Tap Log In.
 Note that you can tap End of Shift on the Team page to log out.

Repeat steps 1-3 to log in more than one *Secondary Driver*.

Switching driver roles


Since the *Main Driver* is assigned the driving time, switching driver roles is required when the *Secondary Driver* starts to drive.


From the **Team** page:

- 1. Tap the switch to main driver icon .
- 2. Answer Yes to the displayed question.











Unlocking a driver profile

By unlocking your driver profile, you access your ISAAC OnTheGo session and all its features.

From the **Team** page:

- 1. Tap the **Profile** icon next to your name.
- 2. Enter your password.
- 3. Tap Yes.

Note that a yellow stripe appears on the dashboard indicating the *Secondary driver's* session is active, while a green steering wheel appears on the dashboard indicating the *Main driver's* session is active.

Generating a teammate's hours of service

When working in teams, it is possible to generate your teammate's hours of service report during a roadside inspection without having to switch

Transferring team driving time

If a Secondary Driver forgets to switch to the Main Driver role before beginning to drive, driving time will be assigned to the wrong driver. It is possible to transfer driving time from one team member to another to correct this type of mistake.

From the **Dashboard** page:

- 1. Tap Logbook.
- 2. Tap History.
- 3. Select the day on which the driving time occurred.
- 4. Select the driving activity on the grid.
- 5. Tap Transfer.
- <u>6.</u> Select the driver to transfer the driving time to.
- 7. Enter an explanation note.
- 8. Tap Save.

Note that it can take up to 10 minutes before the transfer is reflected in the daily logs.











Removing a driver

If a driver who is not part of your team appears on the *Team* page, you can remove his name from the list without affecting his hours-of-service status.

From the **Team** page:

- 1. Tap Remove Operator.
- 2. Tap the icon next to the driver to remove.
- 3. Enter your Username.
- 4. Enter your Password.
- 5. Tap Remove Driver.









Good to know

- ISAAC OnTheGo notifies you of elements that require your attention, such as unassigned driving, unapproved motor carrier logbook modifications and unsigned daily logs. and changes in access rights to the *Yard Move* and *Personal Conveyance* activities since your previous login.
- These notifications are displayed on a different page upon login, which can also be accessed on demand.
- You can act on the various notifications directly from the notifications page.

Accessing driver notifications


1. Tap the notifications icon on the application bar.

The elements that require your attention appear on screen:

- unassigned driving,
- unapproved motor carrier logbook modifications,
- unsigned daily logs,
- missing document references in the daily log header,
- changes to Personal Conveyance and Yard Move activities access rights since your previous login,
- confirmation to keep Yard Move enabled after powering off the truck without deactivating it,
- wheels needing retorque.

Note that elements with arrows require you to take action. Elements with an information icon ① require no actions.







Reviewing unassigned driving

ISAAC OnTheGo keeps records of all driving activities. Unassigned driving occurs if the vehicle is moving and no one is logged into the vehicle's tablet.

All drivers that log in following unassigned driving are prompted to review the unassigned driving activities and take appropriate action.

From the **Notifications** page:

- 1. Tap Unassigned driving detected.
- 2. Select the unassigned driving activity to review.
- 3. Tap Confirm to modify your logbook to include the unassigned driving time, or Reject to leave your logbook unchanged.


Note that a driver icon so is displayed beside activities modified to include the unassigned driving.


Only confirm unassigned driving time that belongs to you as this affects your remaining driving time. Otherwise, select Reject.

Note that an unassigned driving time notification will appear on the notifications page until it is either *confirmed* or *rejected*.

See Rejecting unassigned driving if you have accepted a driving segment that isn't yours.









Reviewing unapproved carrier modifications

For ELD compliant systems, ISAAC OnTheGo notifies you when a modification to your logbook changes your hours-of-service status, and prompts you to review it and take appropriate action.

From the *Notifications* page:


- <u>1.</u> Tap Modifications to your daily logs need your attention.
- 2. Tap the unapproved logbook modification to review.
 - Note that only the modifications affecting your hours-of-service status need your approval.
- 3. Tap **Confirm** to modify your logbook to include the modification or **Reject** to leave your logbook unchanged.
 - An explanatory note is required when a modification is rejected.


Completing a wheel retorque

A notification appears on the tablet when a wheel retorque is necessary. ISAAC OnTheGo allows you to complete a wheel retorque form that can then be viewed by the dispatchers. Note that if there is more than one request, they will be displayed one after the other.

On the *Driver Notifications* page:

- 1. Tap the message indicating the wheel that needs to be retorqued.
- 2. Complete the form on screen.
- 3. Tap Save.











Approving your daily logs

ISAAC OnTheGo allows you to sign daily logs for the previous 14 days, either individually or in a batch.

You could also be required to sign your previous unsigned logs before logging out at the end of your workday, or before completing a vehicle inspection.

On the *Driver Notifications* page:

1. Tap Some daily logs are not signed.


To sign an individual daily log:


- 2. Select a daily log from the list.
- 3. Tap Sign.
- <u>4.</u> Check the **Sign the document electronically** box.
- 5. Tap Yes.

To sign all daily logs in a batch:


- 6. Tap Approve All.
- 7. Check the Sign these documents electronically box.
- 8. Tap Yes.

Green checkmarks appear next to each daily log to show they have been signed.













Compliance Malfunctions and Data Diagnostics



Good to know

- In ELD compliant systems, ISAAC OnTheGo detects and logs all compliance malfunctions and data diagnostic events.
- The driver is alerted to the presence of a compliance malfunction or data diagnostic by an icon color change.
- The driver can consult a list of the compliance malfunctions and data diagnostics with their code, description, detection time and date, and state to cross reference it to a document (onboard the truck) containing detailed information and the possible required actions.

Understanding the compliance malfunction and data diagnostic icon

An icon serves as a visual cue to the presence of either a compliance malfunction, a data diagnostic, or both:

- In no malfunctions or data diagnostics
- a compliance malfunction is present
- Za data diagnostic is present
- both a compliance malfunction and data diagnostic are present



Compliance Malfunctions and Data Diagnostics



Managing compliance malfunctions

- 1. Tap the compliance malfunction and data diagnostic icon showing the compliance malfunction.
- 2. Take note of the malfunction and provide written notice to the motor carrier.
- 3. Reconstruct the record of duty status (RODS) on graph-grid paper logs that comply with FMCSA's 49 CFR 395.8 if data for the current 24-hour period, and for the previous 7 consecutive days cannot be extracted from the tablet.





Consulting data diagnostics

1. Tap the compliance malfunction and data diagnostic icon showing the data diagnostic.

Refer to Appendix A – Malfunctions and Diagnostics for more information on the data diagnostic and possible required actions.







Good to know

- ISAAC OnTheGo enables the driver to perform inspections from the *Inspections* section or the *Activities* screen for the vehicle and hooked equipment.
- The dispatcher can view an inspection report after the driver has applied his electronic signature.
- The inspection status is displayed with an icon indicating whether the inspection is current (green), about to expire (yellow), or already expired (red).
- The inspection items are tagged with a severity level (major, minor, unregulated) that indicates, based on the reported defects, whether the vehicle can make the trip or if repairs are required before leaving.
 - > Reported defects remain at the top of the following inspection reports until repairs are recorded.
- The inspection report can include signatures from the vehicle inspector, up to four different drivers, and the next-day driver (for inspections in the U.S).
- Drivers can record post departure defects that appear in a different column in the inspection report.
- Drivers can record repairs on reported defects on current and expired inspections.
 - Partial repairs can be performed, allowing to repair defects separately when more than one defect is declared in an inspection.
- When a reported defect is repaired but does not show as such, it can be noted as being repaired on a new inspection report allowing the driver to travel with a valid inspection.

Filling out an inspection report

See section Driver Activities, SUPER-ACTIVITY – Inspection (DVIR)



Viewing an inspection report

The vehicle and hooked equipment numbers have different colors to show the status of the inspection report at a glance.

- Black: inspection is valid, no defect detected
- Yellow: inspection expires in 2 hours or less
 OR a minor defect was declared
- Red: inspection is expired, OR

 a minor defect was not repaired within the

 48-hour limit, OR

 a major defect was declared
- **1.** Select **Inspections** on the main menu to display the list of existing reports.

The left-hand side of the list shows a summary status for each inspection:



- minor defects
- major defects

It also shows if the inspection is still valid:





- **4.** Press the tablet's **Return** button to return to the reports list.













Adding a signature to an inspection report

- 1. Tap a button at the bottom of the report to add one of the following signatures:
 - the **driver** signature, if a **different** person inspected the vehicle
 - up to **four driver** countersignatures (on current and expired inspections)
 - the **next-day driver** signature (U.S. inspections)
- 2. Sign in the space provided.
- 3. Tap Save.

Note that all signatures and countersignatures are displayed in the roadside inspection report.



On the inspection report:


- 1. Tap On road breakdown.
- 2. Tap the ellipsis button ____ next to the inspection item.
- 3. Slide the button to record a *Fail* status and enter a note if required.

Including a picture


- 4. Tap the camera icon.
- 5. Tap the blue button to take the picture.
- <u>6.</u> Tap **Done** to return to the previous screen. (or **Cancel** to take a new picture)















Saving the defect

7. Tap **Save** to return to the inspection report.

Signing the inspection report

- 8. Tap Sign at the bottom of the report.
- 9. Sign in the space provided.
- **10.** Tap **Save**.

Note that post departure defects are tagged as such in the inspection report.

Recording repairs on reported defects

On the inspection report:

- 1. Tap the **Repair** button at the bottom of the screen.
- 2. Enter the repair order number.
- <u>3.</u> Tap the button next to the defect to change the status.

Note that partial repairs are possible, allowing to record repairs separately when there is more than one reported defect.

To add the mechanic's signature:


- <u>4.</u> Tap the signature button at the bottom of the report.
- <u>5.</u> Enter the required information, and sign in the space provided.
- 6. Tap Save.

To add the carrier's signature:

7. Repeat steps 4, 5, and 6.









Good to know

- ISAAC OnTheGo enables the driver to enter work shift activities.
- The activities page contains activities specific to your organization.

 It allows the driver to select from ALL available activities, as opposed to when entering activities from the dispatcher's trip instructions page (see section Dispatcher Trip for more information).
- Exceptions allow the driver to activate HOS exceptions when required: Personal Conveyance, Yard Move, Adverse Driving Conditions, Deferral of Off Duty Time (Canada only), 16-hour Short Haul Exception (United States only, etc.).
- Activities allow the driver to confirm an activity is taking place and enter any related information when applicable (ex. number of litres for the *fueling* activity). Depending on the activity, he may also provide a signature, take a photo, scan a document or barcode.
- **Super-activities** allow the driver to carry out a series of operations related to an activity (ex. pre-trip inspection). Super-activities are described in detail later in this section.
- The driver provides activity details on an electronic form where he can key in information, apply electronic signatures, take photos and scan documents.
- Activities can be configured to trigger email notifications, to signal events such as:
 - driver wait times to dispatchers
 - client wait times to customer service
 - mechanical breakdowns, accidents or failed pre-trip inspections to fleet managers
 - departure of cross-border shipments to persons responsible for customs clearing (for preparing PARS documents)
- Some activities affect the driver's service hour status (Off-duty, Sleeper, On-duty), while others are simply informative and do not affect the driver's service hours. For example, a driver might use an informative activity to signal a delay in an activity.
- When the driver enters an activity that affects service hours, the change is automatically reflected on the daily log. It is possible, however, to adjust logbook activities when required.
- ISAAC OnTheGo automatically controls the *driving* activity:
 - > The *driving* activity is activated automatically based on certain criteria.
 - For AOBRD compliant systems, driving is activated if the vehicle is moving at a speed greater than <u>18 km/h</u> or has travelled more than <u>3.3 km</u> (underlined values are configurable).
 - For ELD compliant systems, driving is activated if the vehicle is moving at a speed greater than **8 km/h**.
 - Note that the distance travelled is reset to zero when the vehicle is stationary for more than <u>5 minutes</u>.



Good to know (continued)

- > The *driving* activity is **deactivated if:**
 - the vehicle comes to a stop and remains stationary for more than 5 minutes, or the engine is turned off (RPM=0), or the parking brake is activated, or the driver taps on the **Exit driving mode** button.
 - With ELD compliant systems, if the driver does not confirm they have stopped driving, 6 minutes of driving time will be added to their logbook.
 Drivers must confirm they have stopped driving and are now on-duty when they stop and pull the brake or turn the vehicle off.
- While the *driving* activity is active
 - > The dashboard displays automatically.
 - > The driver cannot access other ISAAC OnTheGo features or Android apps, to promote safe driving.
 - > The driver receives priority messages from the dispatcher in text-to-speech mode for security reasons.
- Before starting to drive, the driver can define the driving type. By default, the system records **Regular driving**, which AFFECTS the available driving hours. However, the driver can select the **Yard move** or **Personal conveyance** activities from the Exceptions page, which DO NOT AFFECT available driving hours.
- When the **Regular driving** and **Yard move** activities **end**, the driver must enter a new activity. ISAAC OnTheGo displays the most relevant activities page based on the vehicle's location (detected by geolocation). The system issues regular reminders to the driver until an activity is entered.
- When the **Personal conveyance** activity ends, the driver remains in the *Off*-Duty status until a new activity is defined.

Viewing the driver's status (service hours)

1. View the driver status at the bottom of the main menu. The status duration is shown in brackets [].

Note that when the driver is driving, the dashboard is in full-screen mode and the main menu does not appear.





Recording the driver's activity

- 1. Tap the **driver status** at the bottom of the main menu.
- 2. Select the activity you are about to perform.

If the activity does not appear on the page:

- Tap the arrows to scroll through the favorite activities' pages.
- Tap the More button to see all available activities.


If a **Warning** indicates the log is signed:

<u>3.</u> Tap **OK** to continue or **Cancel** to interrupt the operation.

Complete the operation

- 4. Enter the requested details (vary based on the activity).
- 5. Tap Save.

The new status appears at the bottom of the main menu and on the daily log.











Using hours of service exceptions

ISAAC OnTheGo allows you to activate hours of service exceptions in certain conditions, when necessary:

Yard Move and Personal conveyance – See *Specifying the different driving exceptions – Yard move and Personal conveyance* for more information.

Adverse driving conditions – allows to add up to two hours of driving time if unknown bad weather conditions occur while driving that could not be foreseen prior to beginning the trip.

Daily off duty deferral (Canada only) – allows to split the off-duty time over any two consecutive days by deferring a maximum of two hours of the daily off-duty time from the first day to the second day and increasing the total of driving and on-duty times in the first day by no more than two hours. However, the work shift hours must still be respected.

100-mile short haul exception (United States only) – allows to extend the 14-consecutive-hour driving window to 16 hours once every 7 consecutive days. Certain conditions must be met to use this exception.

Livestock transportation exception (United States only) – allows to be exempted from taking the 30-minute mandatory break after 8 hours of driving when transporting livestock. The 30-minute break is required as soon as the exception ends if driving time exceeds 8 hours.

Oversize/overweight exception (United States only) – allows to be exempted from taking the 30-minute mandatory break after 8 hours of driving when transporting oversized or overweight cargo. The 30-minute break is required as soon as the exception ends if driving time exceeds 8 hours.




To activate an exception:

- 1. Tap the **driver status** at the bottom of the main menu.
- 2. Tap the Exceptions button.
- 3. Select the exception to activate.
- 4. Enter an explanation note.
- 5. Tap Save.

A grey bar is displayed on the dashboard with a mention of the exception in use.

Note that in the case of a daily off-duty deferral, the message displayed will change based on how far along the day is, the total of off-duty time deferred, and whether it is Day 1 or Day 2.











Specifying the different driving exceptions – Yard Move and Personal conveyance

ISAAC OnTheGo allows to choose the driving type for the driver's needs.

Unless otherwise specified, the system records:

• Regular driving, which affects the available driving hours.

However, the driver can choose a different type of driving from the exceptions:

- **Personal Conveyance**, which is recorded in the *Off-Duty* status, and does not affect the available driving hours. This driving type is used for personal transportation, for example, driving home. In Canada, a maximum distance of 75 km can be travelled in personal conveyance in a 24-hour period. A notification appears on screen warning you when you have 5 km left in personal conveyance.
- Yard Move, which is recorded in the *On Duty* status, and does not affect the available driving hours. This driving type is used, for example, to move around in the yard to hook or unhook equipment. It deactivates automatically when the vehicle reaches 32 km/h.

To specify the driving type:

- 1. Tap the **driver status** at the bottom of the main menu.
- 2. Tap the Exceptions button.
- 3. Tap the activity button indicating the type of driving you wish to activate.

NOTE: You must enter an explanation note when selecting a driving exception.

Once you start driving, the dashboard displays the driving type in a colored bar. You can no longer access other ISAAC OnTheGo features or Android apps, to promote safe driving.

Once you stop driving, ISAAC OnTheGo displays the appropriate page according to the driving type.

To exit Personal Conveyance or Yard Move, tap the colored bar and confirm you wish to deactivate it.











Confirming the end of the driving activity


When ELD compliant, drivers must confirm they have stopped driving and are now on-duty when they stop and pull the parking brake or turn the vehicle's engine off.


When you are done driving:

- 1. Tap Choose a different activity as soon as you pull the brake or turn the engine off. This will allow you to choose your current activity and change your duty status accordingly.
 Note that if you do not press this button, you will remain in the driving status.
- 2. The ELD prompt will reappear 5 minutes after the vehicle has stopped. If again you do not confirm you have stopped driving by pressing Choose a different activity, you will remain in the driving status for another minute.
 1 minute following the ELD prompt, meaning 6 minutes following the end of driving, the system will automatically change your status

IMPORTANT: These 6 minutes in the driving status cannot be erased or modified.

from *Driving* to *On-Duty*.







Recording the driver's activity after driving

ISAAC OnTheGo requests that a new driver activity be entered when it detects driving has stopped.

- 1. If the End driving mode button displays on the dashboard, tap it to quit the *Driving* mode and to display the activities page.
 - This button displays only for vehicles with a mechanical parking brake not detected by ISAAC OnTheGo.
- 2. If your truck has been idle for over 5 minutes following a driving activity, answer Yes to the question to change to an On-duty status or No to remain in the Driving status.
 Note that if you do not answer, your status will change to On duty automatically after 1 minute.
- <u>3.</u> The activities page displays to allow entering the next driver activity.

Depending on the vehicle's location, the page displayed could be the regular **Activities** (Favorites) page or the activities page featured on the **trip instructions**.

See section *Displaying the activities page* when driving ends for more information.


If no activity is defined:

- **4.** A reminder will display after a certain amount of time (as configured).
- 5. Tap Define to enter an activity, OR Close to ignore the reminder. Reminders will keep displaying at regular intervals until an activity is defined.














Reprinting a crude haul ticket

ISAAC OnTheGo allows you to reprint a crude haul ticket if an issue occurred when trying to print the ticket the first time (paper had run out or the Bluetooth printer connection was lost, etc.)


The crude haul ticket previously generated can be reprinted from the logbook once everything is working again.


To reprint a Crude Haul ticket from the tablet:

- 1. Tap Logbook.
- 2. Tap History.
- 3. Tap the date on which the activity occurred.
- Select the Crude Haul activity from the list of activities.
 - The Crude Haul activity is highlighted.
- 5. Tap the **Details** button.
- **6.** Tap **Print Preview** to generate the ticket preview on the screen.
- 7. Tap Print to reprint the ticket, or tap Back to go back to the previous page.
- **8.** Select the number of tickets to reprint (1-10 copies) and tap **Print**.
- 9. Tap Close to go back to the logbook.
















Displaying the activities page when driving ends

ISAAC OnTheGo displays the most relevant activities page based on the vehicle's location which is detected by geolocation. This will be either the regular **Activities (Favorites)** page or the activities page featured on the **trip instructions**.

The diagram below shows how ISAAC OnTheGo goes about determining which activities page to display.






Recording activity details – Taking a picture

On the activity's electronic form:

- 1. Tap the camera icon.
- 2. Tap the **blue button** to take the picture.
- 3. Tap **Done** or **Cancel** to take a new picture.









Recording activity details – Scanning a document

The scanning of documents in ISAAC OnTheGo is done using the tablet's **camera**.

To scan a document

On the activity details page:

- 4. Tap the photo scanner icon.
- 5. Hold the tablet above the document. Follow the guidelines on screen until the document is clear and then press on the camera icon to scan the document.


 Repeat this step for all pages to scan.
 - Note that the indications on screen are only guidelines. You can scan the document at any time.
- 6. Tap the checkmark once you are done capturing all your pages.

To modify a scanned document

- 7. Tap the document to modify.
- 8. Use the buttons on screen to adjust the document's orientation or tap **Modify** to adjust the color scale or crop the document.


 Note that you can retake the picture by tapping **Retake** and following steps 1-4.
- 9. Once the modifications are complete, tap **OK**.
- 10. Tap Save to exit the scanner.

Note that buttons are available to **View**, **Cancel** and **Delete all** scanned pages.













Recording activity details – Scanning a document with EBE Ships

The scanning of documents in ISAAC OnTheGo is done using the tablet's **camera**.

EBE Ships Mobile is accessible from any activity form configured with this app.

On the activity details page:

- <u>1.</u> Tap the **photo scanner** icon to launch the EBE Ships app.
- 2. Select the delivery order number and tap Continue.
- 3. Tap **Use Camera** to start the document scanning process. Hold the tablet above the document and press the button to scan the page. Repeat this step for all pages.
- **4.** Align the green frame with the scanned page borders and tap **ACCEPT**. Repeat this step for all pages.
- <u>5.</u> Review, edit, or rescan the pages if needed, then press **Done**.
- 6. Tap Send Completed Batch at the bottom of the screen.
- 7. Tap Send Batch to send the document. Once sent, you will be brought back to ISAAC OnTheGo.
- 8. A green checkmark appears on the screen to indicate the scan was successful. Enter the remaining information and press Save.

Note that scans performed with the EBE Ships Mobile app are managed by EBE and are not saved in the logbook.
















Follow these guidelines when taking a picture to ensure a good quality scan.

- Optimize the ambient light (ex. turning the lights on in the truck's cabin).
- Place the document on a flat surface.
- Make sure there is no direct sunlight or any shadows on the document.
- To take the picture, hold the tablet in landscape orientation (widthwise), and perfectly parallel to the document.
- Close in on the document to take the largest picture possible of the entire document.
- Keep the tablet stable for a sharp image.

Recording activity details – Scanning barcodes

A barcode field on a form allows scanning several barcodes.

On the activity's electronic form:

- 1. Tap the barcode icon.
- 2. To scan a barcode, place the tablet so the red line displayed on the screen is positioned over the barcode.

The information appears on the right-hand pane once the barcode is successfully scanned.

Scan as many barcodes as required.

Note that additional buttons at the bottom of the right-hand pane allow editing and deleting list items (), manually adding an item to the list (), or purging the list contents ().

<u>3.</u> Tap **Finish** to return to the activity's electronic form.



Hold the tablet parallel to the document.

Take the picture from up close, widthwise.

Place the document on a flat surface.

Make sure there is good ambient light, avoiding direct sunlight and shadows on the document.









SUPER-ACTIVITY Hook/Drop (equipment)

To hook equipment:

- 1. Tap Hook/Drop on the activities page.
- 2. Tap Add at the bottom of the equipment list.
- 3. Enter the equipment type and number.

Note that you have to tap the **Finish** button after hooking the equipment in each situation explained below.

If you enter an equipment number unknown to the system:

<u>4.</u> Confirm whether you wish to create a new piece of equipment.

If you are creating a new piece of equipment:

5. Enter the additional information required.

Complete the operation:


- <u>6.</u> Slide the **button** to indicate whether you hooked the equipment.
- 7. Tap Save.The hooked equipment will appear on the list.














If you enter an out-of-service equipment number:

- **8.** Confirm whether you wish to hook the out-of-service equipment.
 - A red OOS icon appears next to the equipment number.
- 9. Tap Save.

The out-of-service equipment will appear on the list with a red OOS icon to indicate its status.



10. Press No to refuse to hook this equipment.
You can select another equipment instead.


OR

Press **Yes** to confirm you still want to hook this equipment.

The equipment is added to the equipment list with a red **X** indicating the recorded defect.

To drop the equipment:

- 1. Tap Hook/Drop on the activities page.
- 2. Select the piece of equipment on the list.
- 3. Tap **Remove** at the bottom of the list.













SUPER-ACTIVITY - Inspection (DVIR)

Creating an inspection report:

- 1. Tap the Inspection (DVIR) button on the activities page, OR the New Inspection button next to the vehicle or equipment on the inspections page.
- 2. Select the vehicle or equipment you are inspecting.
- 3. Tap the **Inspect** button to complete the DVIR. Note that post departure defects appear in a different column in the reports.
- 4. If you're inspecting equipment (semi-trailer) with a license plate, a window displays allowing you to enter the number.
- 5. If you are inspecting equipment and wish to provide the odometer value, tap the Odometer button and enter the value.
- 6. Swipe the page upward and downward to scroll through the list of inspection items. Note the indicators of the left-hand side:
 - − ✓ Success
 - X Fail

Note that previously recorded unrepaired defects will appear at the beginning of the list.

- Minor inspection item (travelling is allowed even if the status is failed)
- Item includes a note or a picture

Declaring a defect

7. Tap the ellipsis button next to the inspection item.
















8. Slide the **button** to record a *Fail* status and enter a note if required.

Including a picture

- 9. Tap the camera icon.
- 10. Tap the blue button to take the picture.
- <u>11.</u> Tap **Done** to return to the previous screen. (or **Cancel** to take a new picture)

Saving the defect

12. Tap Save to return to the inspection report.

Completing an inspection with no defect found


This action allows you to travel with a valid inspection.

When a reported defect is repaired but still showing in the inspection report, it can be noted as repaired while completing a new inspection.


- 13. Tap the ellipsis button ____ next to the inspection item with a reported defect.
- 14. Slide the button to the Success status.
- <u>15.</u> Enter a note and take a picture of the repaired defect.

The note and picture are mandatory.

16. Tap **Save**.















Signing the inspection report

- <u>17.</u> Tap **Sign** at the bottom of the report.
- 18. Sign in the space provided.
- **19.** Tap **Save**.

Note that once the report is signed the dispatcher can view it.







SUPER-ACTIVITY - Roadside inspection (AOBRD compliant system)

This activity allows preparing a report based on the highway controller's requirements.

- **1.** Tap **Roadside inspection** on the activities page.
- 2. Enter the requested information: driver (when working in teams), report language, whether or not to include the circle check, report format, and the number of days to be included.
- 3. Tap **Display** or **Transfer** depending on the selected option.

If you chose **Display Driver Report** as the report format, a window might appears asking to select the application for opening the PDF file.

4. The controller may scroll through the report on the tablet by swiping the page upward and downward.

To resume driving, place the tablet back in the cradle and drive. ISAAC OnTheGo will detect the change and resume.

To go back to your ISAAC OnTheGo session:

- 5. Tap the tablet's return button =.
- **6.** Enter your ISAAC OnTheGo password.

After generating the report:

- **7.** Enter the required information on the activity form.
- 8. Tap Save.











SUPER-ACTIVITY - Roadside inspection (ELD compliant system)

This activity allows to either transfer ELD data via email or display it on screen when a roadside inspection takes place in Canada, or transfer ELD data via Web Services or email when in the U.S.


- <u>1.</u> Tap Roadside inspection on the activities page.
 - The page displayed depends on whether the roadside inspection takes place in the U.S. or in Canada.
- 2. If the country displayed is not the country you are in, select the **Country** you are in.
- 3. Select the **Driver**.





When in Canada:

- 4. Select the Language.
- 5. Select whether to include the Circle check.
- 6. Select Display Driver Report (on screen) or Transfer Via Email and enter the required email address.
- 7. Tap **Display** or **Transfer** depending on the selected option.





When in the USA:

- 1. Select the transfer method:
 - Web Services or Email.

Note that the correct email is already programed in the tablet and cannot be entered manually.

- Enter a comment if requested by the roadside inspector, such as the officer's identification number.
- 3. Tap Transfer.
- **4.** If the transfer is successful, tap **OK** and proceed to step 7.

A message is displayed when a server issue is making the ELD data transfer unsuccessful. If it happens, the information can be displayed on the tablet:


- 5. Select Display Driver Report.
- **<u>6.</u>** Tap **Display** to view the report on screen.

In Canada and in the USA:

To resume driving, place the tablet back in the tablet dock and drive. ISAAC OnTheGo resumes automatically.




















Sending your ELD records by email

ISAAC OnTheGo allows you to send your ELD records to the email of your choice.


On the dashboard:


- 1. Tap Logbook.
- 2. Tap History.
- 3. Tap Get my ELD Records.
- <u>4.</u> Enter the email address where the file should be sent.
- **5.** Tap **OK**.
- 6. Tap OK again.

The recipient will receive an email from ELD@isaac.ca containing the ELD records.











SUPER-ACTIVITY Shift end or Tractor change

This activity terminates the ISAAC OnTheGo session.

Drivers will need to log in again when starting a new work shift or when starting to work on a new tractor.

They could also be required to sign their previous unsigned logs before logging out at the end of their workday.

1. Tap Shift end or Tractor change on the activities page.

If some daily logs are unsigned:

2. Specify if you wish to sign daily logs before logging off.

If prompted to sign daily logs before logging off:

3. Select the logs and include your signature as instructed in section *Signing the daily* log.

Complete the operation.

- 4. Enter a note if required.
- 5. Tap Save.

The screen will show the activity was successfully recorded and display the login window.











Good to know

- ISAAC OnTheGo shows the instructions entered by the dispatcher via your organization's transport management system (TMS).
- The instructions include the planned trips, stops and related activities.
- The dispatcher can assign a trip to a specific vehicle.
- Drivers complete the planned activities carried out on each stop and can complete unplanned activities as well.
- Planned activities listed on trip stops can include pickups and deliveries that allow the driver to manage multiple shipments (typically used by LTL transporters), enter exceptions and accessorial charges, require customer signatures, and confirm date and time stamps.
- Planned activities listed on trip stops can include crude haul transportation that allows the driver to fill a hazard assessment checklist, select a ticket type, enter charges and customer references when needed, require customer signature, and to preview and print up to 10 crude haul tickets at a time.
- Drivers can make the stops of a trip in any order; however, activities must be carried out in the order on the list.
- On the list of stops, the drivers can choose to display all stops, completed stops, or remaining stops.
- The next planned stop on a trip in progress is displayed on the dashboard while the driver is travelling.

 If a driver makes the stops in a sequence different than the one planned, he can identify his next stop so that it displays on the dashboard.
- Drivers can select their stop from a list or create a new stop if it isn't part of the list.
- If CoPilot[™] Truck is activated, the address of the next stop in the trip instructions is automatically entered on the navigation panel.
- ISAAC OnTheGo can issue notifications when vehicles approach, enter and exit a stop zone included on the trip instructions. When used in the integration of your organization's TMS (Transport Management System), these notifications allow automating actions such as notifying dispatchers or emailing clients to advise them of incoming merchandise.



Viewing trip instructions

Dispatcher instructions include information on the various trips, stops and related activities, and show the status of these different elements:

O To do ; O In Progress ; O Completed

To view the list of trips:

1. Select **Trips** on the main menu.

It is possible that the trip is assigned to a specific vehicle. If so, the vehicle number will be written in red on the trip if you are not in the assigned vehicle.


To view the stops on a trip:

- 2a. Select a trip from the list.This will show the stops on the selected trip.OR
- 2b. Select Stops from the main menu. This will show the stops of the trip in progress. The stops page will show all stops by default. Toggle between viewing all stops, completed stops, or remaining stops by taping on the 3-state button.

To view the activities on a stop:

- 3a. Select a stop from the list.This will show the activities on the selected stop.OR
- <u>3b.</u> Select **Activities** from the main menu. This will show the activities on the stop in progress.









Starting a trip

ISAAC OnTheGo detects the start of a trip **automatically** when the driver enters the first activity or when the driver presses on the *Start trip* button.

<u>1.</u> On the trip page showing the list of stops, tap the **Start trip** button.

Note the button only appears if the trip is not yet started.

If the trip is assigned to a specific vehicle, the trip cannot begin unless the driver is in the specified vehicle.

Once the trip is started, its number appears on the header band displayed on most ISAAC OnTheGo pages.







Selecting the current trip stop location or creating a new stop location

When a driver arrives at a trip stop, ISAAC OnTheGo displays a list of stops within the zone allowing the driver to select the stop they are at from the list. If the stop does not appear in the list, the driver can create a new stop.

To select a stop location:

1. Tap on the **stop location** from the list.

Note that the stops are listed from nearest to furthest.

If the stop does not appear in the list:

- 2. Tap Create a new client.
- 3. Enter the client's name.
- 4. To include the stop address, slide the button to **Yes** next to the **Create address** field and enter the stop address.
- 5. Tap Save.
- 6. Tap Return to the detected clients list to return to the list of stops.
- 7. Tap Save.







Indicating the next stop on the trip


ISAAC OnTheGo automatically displays the next stop on the driver's dashboard. By default, it displays the stops in the order of appearance on the trip.

If the driver is not following the planned sequence, however, he can indicate the next stop he plans to make.

NOTE: The stops page shows all stops by default. The driver can choose to display all stops, completed stops or remaining stops using the 3-state button at the bottom of the list.

- 1. On the trip page showing the list of stops, select a stop, and tap the More button, or keep pressing on the stop to display the activities menu.
- 2. Select option Define as next stop.
 If CoPilot[™] Truck is activated, the stop's address will be entered automatically on the dashboard's navigation panel.
- <u>3.</u> Touch the **blue bar** to activate or deactivate navigation instructions to the next stop.










Automatic detection of vehicles entering and exiting a stop zone

ISAAC OnTheGo can issue notifications when vehicles **approach**, **enter** and **exit** stop zones included on the trip instructions. When used in the integration of your organization's TMS (Transport Management System), these notifications allow automating actions such as notifying dispatchers or emailing clients to advise them of incoming merchandise. If the system detects more than one stop nearby, a message will appear on the tablet allowing to select the next stop.

The diagram below shows the three types of notices ISAAC OnTheGo issues when a vehicle crosses delimited zone borders.






Confirming the planned dispatcher activities

- 1. On the activities list, tap the activity you wish to confirm.
- 2. If a window displays a warning that another stop is currently in progress, reply using one of the buttons displayed:
 - **Continue** —will re-initialize the stop already in progress (i.e. undo the actions already confirmed).
 - Cancel will return to the previous screen and leave the stop already in progress untouched.

After replying Continue:

- 3. Enter the information required, which will be based on the selected activity. for example:
 - An unloading activity may require that you enter a quantity and the state of the merchandise.
 - A *Hook/Drop* activity will show a list of semi-trailers from which to choose.
- 4. Tap Save.










Confirming the next stop directly from the stop activities


Complete the stop activities as usual, then:

- 1. Tap on Next Stop.
- 2. Choose your next stop from the list. The next stop is displayed on the line.
 If an Auto-Departure activity is planned, it will be displayed after the Next Stop activity.
- 3. Repeat steps 1 and 2 for every trip stop.Note that only the remaining stops are listed.
- <u>4.</u> Tap **Confirm** for the last stop of your trip instead of choosing a stop.











Entering an unplanned activityon the trip instructions page

- 1. Tap and hold an entry on the list of
 - **1a** trips
 - **1b** OR stops
 - 1c OR activities

Note that on the stops and activities page, you can also tap the **Plus** button.

- 2. Select an activity from the list.
 - Note that the activity is automatically linked to the trip, stop or activity on which it is entered.
- <u>3.</u> Enter the required information (varies based on the activity selected).
- 4. Tap Save.

Entering an unplanned activity on the Activities (Favorites) page

This option allows the driver to choose from all activities available in ISAAC OnTheGo.


Activities entered here will automatically be linked to the current trip.

- 1. Tap the Activities (Favorites) button to display the activities page.
- 2. Continue as described in section Recording the driver's activity.

















Completing pickup and delivery activities

ISAAC OnTheGo allows to complete pickup and delivery activities involving multiple shipments, typically required by LTL (less than truckload) transporters. The driver can complete required shipment information, enter accessorial charges and exceptions, confirm arrival/start/end times, and include customer signatures.

Viewing dispatcher notes

Tap the **Notes** button at the bottom of most pages to view notes entered by the dispatcher.

- **1**. On the activities list, tap the pickup or delivery **activity** you wish to begin.
 - The activity's list of shipments is displayed, Arrival and departure activities automatically complete when arriving and leaving the stop.
- 2. If required information is missing from one of the shipments (highlighted in red), tap it to enter the required information.
 - If no shipment is highlighted, skip to step 5. Note that an error message will appear if you tap on **Next** without completing the required information.
- 3. Complete the required information in the shipment or scan the barcode if available.
 A message might inform the driver that a trip update is needed before continuing. The driver can refresh the trip without losing the information already entered.
- 4. Tap **Save** to return to the shipment list.











- 5. If the Accessorial Charges and Exceptions buttons are present, tap them to either activate (blue) or deactivate (gray) the entry of such information while completing the pickup or delivery activity.
- 6. Tap Next.
- 7. If the Accessorial Charges page displays:
 7a Select a charge that applies,
 7b Select the shipments with this charge.
 7c Tap OK.

Repeat step 7 until all applicable accessorial charges have been entered.

- 8. Tap Next.
- 9. If the Exceptions page displays:
 - **9a** Select a shipment for which exceptions apply.
 - **9b** Select the exceptions for the shipment
 - **9c** Enter the required information.
 - 9d Tap OK.

Repeat step 9 until all applicable exceptions have been entered.

10. Tap **Next**.
















- **11.** Verify that all dates and times on the **Additional information** page are accurate and tap on the date and time entries you want to modify.
 - **Arrival** Time at which you entered the stop zone
 - Start Time at which you began the delivery or pickup activity
 - End Time at which you are completing the current delivery or pickup activity (current time)
- <u>12.</u> Add the additional information if any is required.
- 13. Tap Next.
- **14.** Have the customer sign their name if required and type their name below the signature using the on-screen keyboard.
- **15.** Tap **Save**.









Splitting items of different dimensions


When needed, you can split your shipment items if they do not have the same dimensions.

On the item's page:

- 1. Tap Split.
- 2. Enter the Quantity with the current dimensions and the Quantity with different dimensions.
- 3. Tap Save.
- 4. Enter the dimensions of the split items.
- 5. Tap **Save** to return to the shipment page or tap **Split** to split the item again.
 - A second line of items appears on the shipment's page and each item's quantity is adjusted.
- 6. Tap Save to return to the shipment list.









Alternatively, the **Split** button might not be displayed on this page. If that is the case, the shipment items can be split directly from the field where the items' dimensions are entered (cubage).

Enter the dimensions and the quantity of items of the same size, and press + to add items of different dimensions.





Adding shipments to a pickup activity

ISAAC OnTheGo can be set up to allow adding shipments to a pickup activity. When this is the case, an **Add** button is displayed at the bottom of the shipments list.


On the shipment list:

- 1. Tap Add.
- 2. Enter the shipment information:
 - shipment number (can also be scanned using a barcode scanner)
 - consignee
 - destination
 - weight
 - quantity and type of merchandise
- 3. To add shipment items
 - **3a** Tap the + button.
 - **3b** Enter item details.
 - 3c Tap Save.

The new shipment is added to the list on the pickup activity.

Repeat step 3 until all shipment items have been entered.









Cancelling a shipment from a pickup and delivery activity


When needed, you can cancel shipments from a pickup or delivery activity. The cancelled shipment and the cancellation reason are sent back to the dispatcher through the TMS system.


From the shipment list:

- <u>1.</u> Tap the shipment you wish to cancel. The shipment information window opens.
- 2. Tap the bin icon
- 3. Select a reason from the list on the left and enter a comment if needed.
 Note that the Save button will be greyed out until a reason is selected.
- 4. Tap Save.
 The deleted shipment is highlighted in grey in the shipment list.
- 5. Tap **Next** and complete the rest of the pickup and delivery activities for the other shipment items.


If all shipment items are cancelled, tapping **Next** opens a window to confirm no shipment item was picked or delivered for this stop.













Completing crude haul transportation activities

ISAAC OnTheGo allows to complete crude haul transportation activities. The driver can fill a hazard assessment checklist, select a type of ticket, enter charges and customer references when needed, add customer signatures, and preview and print a crude haul ticket.

To complete a crude haul activity:

- 1. On the activities list, tap the crude haul activity.
- 2. Complete the Hazard Assessment Checklist. Note that all questions must be answered before moving on to the next step in the activity.

To print the checklist before completing the activity:

- 3. Tap Print.
 - **3a** Select the **number of copies** of the checklist to print (between 1-10 copies).
 - 3b Tap Print.
- 4. Tap **Next** to move on to the next step.
- 5. Choose a Ticket Type: metered or scaled. Note that the form is set to Metered by default and can be switched to Scaled.
- 6. Complete the form.
 Note that fields marked with an asterisk * are mandatory.

To add or remove a charge:

7. Tap Charges.











7a Tap **+ Add a Charge** and complete the information concerning the charge,

7b or tap the bin icon to remove a charge.

7c Tap **Close** to save the charges, or **Cancel** to cancel them.

Repeat step 7a until all charges have been entered.

- **8.** Tap **Customer Info** if needed:
 - **8a** Tap **+ Add a Reference** on to add a reference,
 - **8b** or tap the bin icon to remove a reference.
 - **8c**. Tap **Close** to save the references or **Cancel** to cancel them.

Repeat step 8 until all customer references have been entered.

- Tap Next.
- 10. Add the client's signature and tap Next.
- 11. Add your signature and tap **Next**.
- 12. The print preview displays on the screen.

 Note that if you tap **Back** and modify any information, both signatures will be removed.

 Both the client and the driver will have to sign
- again.

 13. Tap Print.
- <u>14.</u> Select the **number of copies** of the crude haul ticket to print (between 1-10 copies).
- **15.** Tap **Done** to complete the activity.
















Good to know

- The hours-of-service information is displayed based on Canadian or U.S. regulations, as indicated by the display mode appearing on the page header.
- The activity the driver records is automatically reflected on the daily log, with the driver status shown as *Off-duty, Sleeper Berth, Driving, On-duty*. It is possible, however, to adjust the logbook when necessary (except for the *Driving* status).
- Logbook activities can be modified, with exception of *driving* activities. The driver can however leave comments for any activity in the logbook, including the *driving* activities.
- The driver can electronically sign multiple daily logs at once, and could be required to sign their previous unsigned logs before logging out.
- The dispatcher can see the driver's service hours in real time.
- ISAAC OnTheGo keeps 14 days of daily logs on the tablet. A complete history is available on the system server.

Viewing the current daily log

- <u>1.</u> Select **Logbook** from the main menu. The current daily log displays.
 - NOTE: Tap the **Header** button to view the current daily log header.
- 2. Tap a section on the graph to display the duration of the corresponding hours of service status.


The logbook header section shows:

- the remaining driving hours in the work shift
- the hours remaining in the work shift and work cycle
- the reset date and time for the work shift and work cycle

When the display mode is set for U.S. regulations, the header section also shows:

- the hours remaining before a mandatory break
- the break duration










Viewing the service hours recap

- 1. Tap History at the bottom of the daily log.
- 2. Tap the RECAP tab.



<u>3.</u> Press the tablet's return button to go back to the list of daily logs.

You can also tap **Header** to display the header of the current daily log.










Understanding the hours-of-service recap

The left side of the recap page shows:

- a. The hours worked per day
- b. The time of the cycle reset
- c. The total hours worked in the last 6 days (CAN rule) or 7 days (U.S. rule) OR the total hours worked since the last cycle reset
- d. The on-duty hours available at the start of the day
- e. The hours worked today
- f. The projected number of on-duty hours available at the start of the day tomorrow, if the driver finishes his workday now
- g. The projected number of on-duty hours available at the start of the day after tomorrow

The right side of the recap page shows:

- h. The remaining hours currently available in the shift
- i. The remaining hours currently available in the cycle
- j. The remaining driving hours currently available





Entering shipping document numbers on the daily log



Signing the daily log

ISAAC OnTheGo allows you to sign daily logs for the previous 14 days, either individually or in a batch.

To sign an individual daily log:

- 2. Select a daily log from the list.
- 3. Tap Sign.

If the **Sign** button is not active, it means the daily log is already signed.

- Check the Sign the document electronically checkbox.
- 5. Tap Yes.


Note that you can tap the **Not Ready** button if you are not ready to sign the daily log.

To sign all daily logs in a batch:

- 6. Tap Approve All.
- Check the Sign these documents electronically checkbox.
- 8. Tap Yes.


Green checkmarks appear next to each daily log to show they have been signed.

Note that the signature will be removed if new activities are entered or if driving is detected.















Activating the split sleeper berth

The Sleeper berth provision can only be used under HOS cycles 1 or 2 in Canada and 70h/8d in the U.S..

- 1. Tap Logbook.
- 2. Toggle the Sleeper Berth Provision button to ON.

The letters **SB** are displayed beside the remaining driving time on the *Dashboard* and next to the *Shift* in the logbook. It remains active until it is manually deactivated.








- 4. Tap Edit.

Note that driving activities cannot be modified.

Driving can be transferred to a team member if the driving occurred while you were logged in as team members. See *Transferring team driving time* for more information.

To change the activity:

An explanatory note is mandatory for all logbook changes.




Adding comments to logbook activities

ISAAC OnTheGo allows you to add comments to logbook activities. These comments are displayed in data transferred to the FMCSA.

- 3. Tap Add comment.

- Tap OK.Repeat steps 3-5 to add another comment to the same activity.
- 6. Tap Close.









Adding additional hours


ISAAC OnTheGo allows the driver to add hours worked in the last 13 days, either for a different carrier or for which they did not have to complete a logbook.

Option 1 – adding hours worked at another carrier

Note that hours worked for another carrier cannot overlap the days (24-hour period) where the ISAAC tablet was used.


- 1. Tap **History** at the bottom of the daily log.
- 2. Tap the Add worked hours button.
- 3. Tap Option 1.
- 4. Select the Day you wish to add hours to.
- 5. Tap Add hours.
- <u>6.</u> Enter the **start time** and **end time** of every duty status activity (driving / on-duty / off-duty / sleeper) for this day.
- 7. Tap Save.
 Repeat for all desired days.
- **8.** Tap **Confirm** when all additional hours have been added for all desired days.

Note that the added hours are to help calculate the remaining driving and on-duty time and are not displayed on the roadside inspection report.











Option 2 – adding hours for which completing a logbook was not required

For example, this option can be used by a driver needing to travel further than the 160 km-radius from the terminal for one day.


- 1. Tap **History** at the bottom of the daily log.
- 2. Tap the Add worked hours button.
- 3. Tap Option 2.
- <u>4.</u> Select the **Day(s)** you wish to add hours to. You can select several days at once.
- 5. Tap Add hours.
- <u>6.</u> Enter a Work shift start time and a Work shift end time for each day worked.
- 7. Tap Save.

Note that these hours will be displayed in the roadside inspection report as manually added hours.












Rejecting unassigned driving

Drivers can reject an unassigned driving segment that was previously accepted by mistake.


- 1. Tap History at the bottom of the daily log.
- 2. Select a daily log from the list.
- 3. Tap the driving activity accepted by mistake. Note that a driver icon is displayed beside activities modified to include the unassigned driving.
- 4. Tap Reject.
- 5. Enter a **note** explaining the rejection.
- 6. Click Yes.

The unassigned driving segment is removed from the driver's daily log and the duty status (on-duty, off-duty, sleeper berth) is restored to what it was before.

Note that an entry is recorded in the logbook to indicate that the unassigned driving segment was rejected.













ISAAC OnTheGo keeps up to 14 days worth of daily logs on the tablet.



Dashboard



Good to know

- The dashboard shows the driver his remaining driving time and driving performance indicators.
- The performance indicators displayed are configurable and established by the system administrator. (ex. accelerator pedal usage, horsepower, fuel consumption).
- The color code of performance indicators shows if values are optimal (green), below optimal (yellow), or need to be rectified (red).
- If CoPilot™ Truck is activated, the navigation screen appears on the dashboard in addition to the performance indicators and navigation instructions can be toggled on and off directly from the dashboard. Traffic conditions will also appear if the Active Traffic™ option is activated.
- The dashboard displays automatically when the vehicle is travelling.

 ISAAC OnTheGo detects the vehicle is travelling when moving at over 18 Km/h or after covering a distance of more than 3.3 Km.
- When the dashboard displays while travelling, drivers:
 - cannot access other ISAAC OnTheGo features or other Android apps, to promote safe driving
 - can safely receive priority messages from the dispatcher, thanks to text-to-speech functionality
 - can safely send a precomposed emergency message rapidly
 - can see the next planned stop
 - receive notifications about any current or impending hours-of-service violations
 - receive notifications about any current or impending inspection violations

Dashboard



Viewing the dashboard

When the dashboard displays while travelling, other tablet functions cannot be accessed, to promote safe driving.

To display the dashboard:

1. Select **Dashboard** on the main menu.

The dashboard displays:

- the remaining driving time
- the next planned stop if trip instructions are activated in ISAAC OnTheGo – navigation instructions can be toggled on and off by tapping the blue bar
- the time remaining before the next mandatory break – if the display mode is for U.S. regulations
- the navigation panel, if CoPilot[™] Truck is activated in ISAAC OnTheGo
- the traffic conditions if the Active Traffic™ option is activated.

When the vehicle is travelling, the dashboard shows:


- driving performance indicators
- the navigation panel, if CoPilot[™] Truck is activated
- The menu bar when the vehicle is stopped for more than 3 consecutive seconds.
- notifications of upcoming hours-of service violations, 30 minutes before the violation



Dashboard



The vehicle's geographical position determines if notifications are issued based on Canadian or U.S. regulations.

- notifications of alarms detected by the gateway (ex. excessive speed, hard turn, etc.)
- Notifications of inspection violations when a vehicle or equipment is moving with an inspection about to expire or already expired
- Notifications of inspection violations when moving with an unrepaired minor defect within the 48-hour limit
- Notifications of inspection violations when moving with an unrepaired minor defect over the 48-hour limit, or unrepaired major defects

Drivewyze



Good to know

- Drivewyze is an application used in trucking to reduce the number of times a driver must stop at a weigh station. It is offered as an option in ISAAC's solution. It integrates directly into the dashboard on ISAAC's tablet. For more detailed information on Drivewyze, go to https://drivewyze.com/support-center.
- Drivewyze informs you at a 2-mile distance and then again at a 1-mile distance from Drivewyze supported weigh stations and instructs you via a message displayed on screen whether to bypass the weigh station, pull in, or follow roads signs.
- Drivewyze records the last instructions given to view if needed.


Following Drivewyze instructions

Drivewyze Instructions appear on screen, remain for a few seconds, and then disappear. No action is required.

On the dashboard:

- 1. When Drivewyze advises of an approaching weigh station, be prepared to follow upcoming instructions.
 - Note that you will be advised of an upcoming weigh station at a 2-mile distance and then again at a 1-mile distance.
- 2. Read and follow the Drivewyze instruction to either bypass, pull in or follow the road signs. NOTE: If you do not have time to read the instruction or are unclear about the instruction, pull in at the weigh station.

- CoPilotTM Truck, a commonly used navigation tool in trucking, is offered as an option in ISAAC's solution. It integrates directly into the dashboard on ISAAC's tablet.
- This section describes how to access some of the most commonly used features. For more information, see CoPilot's Web site and help tools. For more detailed information on CoPilotTM Truck, go to https://support.copilotgps.com
- If ISAAC's solution includes trip instructions from your organization's TMS (Transport Management System), the address of the next defined stop is entered automatically on the CoPilot™ Truck navigator panel.

Changing the vehicle profile

The profile includes information such as vehicle dimensions and specifies if the load includes hazardous materials.


CoPilot[™] Truck takes this information into account when suggesting a route.

On the dashboard:

- 1. Tap the menu icon .
- 2. Tap Settings.
- 3. Tap Vehicle Routing Profiles
- <u>4.</u> Change the vehicle profile using the features on the screen.

Note that you can also change your vehicle profile after having entered your destination.











Activating safety alerts and warnings

On the dashboard:

- 1. Tap the menu icon then **Settings**.
- 2. Tap Safety Alerts & Warnings II
- 3. Slide the buttons to activate the different safety alerts and warnings you wish to see while driving.









Entering a destination address

If ISAAC's solution is integrated with your organization's TMS, there is no need to enter the address manually, as it is automatically taken from the dispatcher's trip instructions and entered in the navigation system.

On the dashboard:

- 2. Enter an address using the features on the screen or tap the favorites icon and choose a destination from your favorites.
- 3. Tap Calculate.

Adding a favorite destination

On the dashboard:

- 1. Tap the search icon .
- 2. Tap the **favorites** icon
- 3. Tap the icon to add a favorite ⊕.

 Note that you can edit an existing favorite by using the edit button ∠.
- **4.** Add the destination as a favorite using the features on the screen.











Good to know

- ISAAC OnTheGo's messaging is dedicated to communication between vehicle drivers and dispatchers.
- Dispatchers can send priority messages and request a reply.
- Dispatchers can send a destination to a driver with a clickable link to set the destination in CoPilot.
- The driver and dispatcher can send a message via satellite if the vehicle is equipped with a satellite communication module.
- Dispatchers can also specify an expiry date and time on a message, so it is removed from the driver's tablet when it expires.
- The retention period for messages on the tablet is configurable in ISAAC OnRecord.
- After reading a message, the driver can go back to the dashboard by tapping the words ISAAC OnTheGo in the upper left corner.
- All messages are announced in the application bar using an icon, and with a sound alarm.
- For priority messages and messages that require a response, the sound alarm repeats at regular intervals until the driver acknowledges the message.
- Dispatchers can deactivate the sound alarm when sending a message, to avoid disturbing the driver during a rest break.
- When the vehicle is travelling, the driver receives messages in text-to speech mode, so he can receive and acknowledge messages safely. Text size and audio message play speed are configurable in ISAAC OnRecord.
- Messages the driver sends are received by all users in the selected dispatcher group.
- The driver can rapidly send a precomposed emergency message, which can prove especially useful while driving. The emergency message is received by all users in the selected dispatcher group as well as all other dispatchers that have configured their email notifications to receive all emergency messages.



Being notified of messages received

- <u>1.</u> Check the indicator bar displayed at the top of ISAAC OnTheGo's pages.
 - the number of unread messages is displayed
 - a red icon signals unread priority messages
- 2. Pay attention to the sound alarm that signals priority messages. Note, however, that the dispatcher can deactivate the sound alarm when sending a message.

When the vehicle is travelling, the driver can safely receive and acknowledge priority messages thanks to **text-to-speech** functionality (see *Viewing and replying to a message* for more information)

Viewing the list of messages received

The list displays showing the most recent messages at the top.

- ➤ A red vertical bar signals priority message
- A status icon helps distinguish read messages (open envelope) from unread messages (closed envelope).












Viewing and replying to a message

- <u>1</u>. Tap a message to display its full contents in a separate window.
 - If the message is part of a conversation with more than one reply, a page showing all replies will open.
- 2. Tap the **text-to-speech icon** to listen to an audio version of the message.
- 3. If the message contains an attachment or a link, tap the name of the document or the link to open it on a new page.
- If the message requires an immediate response, tap one of the response buttons (Accept/Refuse).
- 5. If the message contains a new destination, tapping the link will set the address as the destination in CoPilot and cause the CoPilot page to appear.
- <u>6.</u> To type a custom response, tap the **Reply** button.
- 7. Press the tablet's return button to go back to the messages list.

Note that the message's **status icon** is updated to show the message has been read.











Viewing your archived messages

ISAAC OnTheGo allows you to archive your messages once they are read. If you receive a reply to an archived message, it returns to your active messages.

1. Check the **Show archived** checkbox to view your archived messages with your current messages.

Note that archived messages are highlighted in grey.


Archiving a message

- Tap the message to archive.
 Note that the entire conversation linked to the message will be archived.
- 2. Tap Archive.

Note that all replies to the message must have been read before you can archive the message.









Receiving priority messages

For priority messages, the sound alarm repeats at regular intervals until the driver acknowledges the message.

When the priority message alarm sounds:


<u>1.</u> If the message is not already displayed, tap the messages icon on the indicator bar.

On the message display:

- 2. Tap the **text-to-speech icon** to hear an audio version of the message.
- 3. Tap one of the reply buttons (Accept, Refuse).

Receiving priority messages while driving

When the vehicle is travelling, priority messages automatically appear on screen in **text-to-speech** mode.

On the message display:

 ISAAC OnTheGo will display all priority messages not yet acknowledged before redisplaying the dashboard.

To RE-ACCESS priority messages that have already been acknowledged:

ISAAC OnTheGo will once again display the priority messages already received and will redisplay the dashboard when done.





Sending emergency messages


The emergency messages feature allows you to rapidly send precomposed emergency messages to users in your selected dispatcher group as well as to all users that configured their email notifications to receive all emergency messages.

To send an emergency message:

- 1. Tap on the Emergency Messages icon .
- 2. Select one of the precomposed emergency messages.
- 3. Tap Send.

Note that if you are in an area with no cellular coverage and your vehicle is equipped with a satellite module, the emergency message will be sent via satellite automatically.

If you do not have a satellite module, the message will be sent as soon as you return to an area with cellular coverage.





ISAAC InMetrics



Good to know

• The ISAAC InMetrics option lets you view your most recent performance reports.

Viewing a daily performance report

- 1. Select ISAAC InMetrics from the main menu.
- 2. Select the report you wish to view.
- 3. Swipe the page upward and downward to scroll through the report.



Pinch and stretch the image to zoom in and out.

- 4. Tap the scroll arrows to move through the various reports.
- 5. Tap the **Return to list** button to return to the previous page.





Documents



Good to know

- The document section contains any document your organization has decided to make available via ISAAC OnTheGo.
- Depending on the document format, you might need to install an application on the tablet to view it. For example, the Adobe Reader application is required to view documents in PDF format.

Viewing a document

- 1. Select **Documents** from the main menu.
- 2. If the document you wish to view does not appear on the Recently viewed documents list, tap the All documents button.
- 3. Select the document you wish to view.
 - A window will appear for selecting the application you wish to use for displaying the document.
- **4.** Swipe the page upward and downward to scroll through the document.





Applications



Good to know

• The applications feature provides access to other apps (applications) installed on the android tablet, directly from within ISAAC OnTheGo.

Accessing an application

- 1. Tap Applications on the main menu.

 If this option does not appear, swipe the menu upward to show options appearing at the bottom of the list.
- 2. Tap the icon of the application you wish to start.
- 3. Tap the tablet's return button to return to ISAAC OnTheGo.





Accessing the internet

ISAAC OnTheGo allows you to access company approved websites directly on the tablet.

Note that to activate this feature, an administrator must contact an ISAAC client success manager with the list of company-approved websites.

- 1. Tap Applications on the main menu.
- 2. Tap the Internet icon.

An approved default website will open on a new screen.





ISAAC OnTheGo detects two types of anomalies: *Data Diagnostic Events (DDE)* and *Malfunctions*.

Both are signaled to the driver by illuminating an indicator icon in the upper right corner of the tablet. When a Data Diagnostic Event is recorded, the indicator in the top left part of the icon lights up by becoming red ($\boxed{2}$). When a Malfunction is detected, the indicator in the bottom right part of the icon also lights up in red ($\boxed{2}$). Note that having both indicators illuminated ($\boxed{2}$) means a data diagnostic event and a compliance malfunction are present.

Refer to the codes below (corresponding to the codes on the tablet) for details on possible data diagnostic events, malfunctions, and required actions.



Under Canadian ELD rules, carriers must take appropriate actions to correct a Data Diagnostic Event or Malfunction within 14 days of becoming aware of it. That limit can be extended to the moment the vehicle returns to its home terminal from a planned trip that exceeds the 14-day period. Carriers must also keep a register of all Data Diagnostic Events and Malfunctions recorded on their ELDs. It is understood that information about the steps taken to resolve them will be entered in this register. As such, the recommendation to do so is not given for each data diagnostic event or malfunction listed below.

Under US rules, carriers must take appropriate actions to correct a Malfunction within 8 days of becoming aware of it. An extension can be requested to the FMCSA Division Administrator for the State of the motor carrier's principal place of business within 5 days of becoming aware of the Malfunction. Also, although no register of Malfunctions is required, it is advisable to keep track of Data Diagnostic Events and Malfunctions and the actions taken to correct them.
